• Guideline Updates, Application Priorities, Usage of Prior Year Allocations

Program will reopen June 10th-July10th, more information will be available on our website. It will be prioritized based on needs. Applicants who have previously used the program must

utilize the grant and loan portions. Borrowers must not have any outstanding, city, county, or school taxes or the borrower must be on a payment plan.

HAP Project Documents Required:

Income and tax verification, proof that they own the home, closing documents,

Guideline updates:

Borrowers who have previously received HAP in the past 5 years from final inspection will not be able to reapply.

If a homeowner decides they only want to utilize the \$5,000.00 grant they will be responsible to find their own contractor for their project and they will notified that the URA will not be warranty the work.

Application Priorities:

- 1. Need (Severity of conditions in the home and city code violations)
- 2. Households with Children 5 years or younger
- 3. Households with children or an adult with asthma diagnosis
- 4. Households with seniors or someone on SSDI
 *Once we have created a new list of applicants who meet the prioritization criteria will be randomly selected for final approval)
