Revision of Invitation for Bids, page AB-1 of the Contract Documents:

Revise the first paragraph to read as follows:

The **URBAN REDEVELOPMENT AUTHORITY** of Pittsburgh will receive bids from qualified contractors for remediation and demolition of the former Homewood School located at 7100 Hamilton Avenue, Pittsburgh, PA 15208, and all work incidental thereto required to complete the contract until 11:00 a.m. prevailing time on **Friday, the 11th day of May, 2018**, at its office, 11th floor, 200 Ross Street, Pittsburgh, Pennsylvania 15219, at which time all bids will be publicly opened and read aloud in the 11th floor conference room, 200 Ross St., Pittsburgh, PA 15219.

Revise the last paragraph/sentence to read as follows:

Bids may be held by the Urban Redevelopment Authority of Pittsburgh for a period not to exceed **one hundred and twenty (120) days** from the date of opening of bids for reviewing the bids prior to awarding the Contract.

Revision of B-1, Homewood School Demolition and Site Clearance, page B-1 of the Contract Documents:

Revise the second paragraph to read as follows:

2. In submitting this Bid, the bidder understands that the right is reserved by the Urban Redevelopment Authority of Pittsburgh to reject any and all bids. If written notice of the acceptance of this Bid is mailed, emailed or delivered to the undersigned within **one hundred and twenty (120) days** after opening thereof, or at any time thereafter before the Bid is withdrawn, the undersigned agrees to execute and deliver an agreement in the prescribed form and furnish the required bonds within ten (10) days after the agreement is presented to him for signature.

The Bid Form, page BP-1 of 1 has been revised to remove ambiguity in line 5 regarding sewer disconnection. The revised form is attached as part of this addendum.

The Bid Bond form was inadvertently left out of the bid package. Revised BP-1 is attached as part of this addendum. Please discard the original bid form, BP-1 and replace with Revised BP-1

Revision of Section 401.4, Time for Completion, of Special Conditions Part 1, page SC1-2 of the Contract Documents:

Revise to read as follows:

The work which the Contractor is required to perform under this Contract shall be commenced at the time stipulated by the URA in the "Notice to Proceed" to the Contractor and shall be fully completed in 90 consecutive calendar days. Anticipated Notice to Proceed is November 1, 2018.

Revision of Section 401.17, Water and Sewer Disconnections, of Special Conditions Part 1, page SC1-5 of the Contract Documents:

Revise to read as follows:

This project requires the capping of water and sewer service lines both at the building and at the main.

Revision of Section 511, Site Clearing Demolition, of the Technical Specifications, page TS-6 of the Contract Documents:

Revise as follows:

There are two sections "B". Change the first to "A", and add the following language to the existing text:

All existing paving shall remain in place.
