

NOTICE OF PUBLIC HEARING

The Urban Redevelopment Authority of Pittsburgh (the "**Authority**") will hold a public hearing on July 29, 2021 at 4:30 p.m., to discuss the issuance by the Authority one or more series of its tax-exempt or taxable revenue bonds (the "**Bonds**"), the proceeds of which shall be used, along with other available funds, for the following project (the "**Project**"):

- A. Initial Owner: Prestigious Hills LP (the "**Borrower**"), a Pennsylvania limited partnership, whose address is 1101 30th Street NW, Suite 400 Washington, DC 20007.
- B. Maximum Principal Amount of Bonds: An amount not to exceed \$12,000,000 (exclusive of any original issue discount or original issue premium).
- C. Location of Project: Multiple housing units located proximate to the 13th ward of the City of Pittsburgh in the zip code 15221-1011.
- D. Description of Project: The Project consists of (a) relating to the rehabilitation of approximately 117 scattered site affordable rental units, all located in the City of Pittsburgh, Pennsylvania; (b) the payment of a portion of the costs associated with the issuance of the Bonds; and (c) the payment of any other eligible costs for which proceeds of the Bonds may be expended, including but not limited to reimbursing the Borrower for costs incurred for the Project prior to the issuance of the Bonds.
