

URA Sustainability Policy

The Urban Redevelopment Authority's sustainability policy is designed to help developers incorporate "green" features into their projects.

URA staff, along with representatives from the Green Building Alliance (GBA), will work with the development team to provide information, set project sustainability goals, and determine strategies to meet those goals.

Development teams will make a good-faith effort to make their project as environmentally sustainable as possible. The goals, strategies and features determined by development team, URA staff and GBA representative will be documented in a project Sustainability Plan. The URA will monitor the project's progress in accomplishing the objectives defined in the Plan.

Step 1

CONTACT INFORMATION
Complete attached eligibility and preliminary information sheet and return to your URA project contact.

Step 2

THIRD-PARTY VERIFICATION
If a project will be seeking a third-party certification, the URA will send a checklist specific to that certification. Development team shall complete the checklist, send a copy to the URA project contact and bring a copy to the upcoming meeting with URA contact and GBA representative.

If a project is not planning on seeking a third-party certification, the URA will send a general questionnaire. Development team shall complete the questionnaire, send a copy to the URA project contact and bring a copy to the upcoming meeting with URA contact and GBA representative.

Step 3

SCHEDULE SUSTAINABILITY MEETING
URA contact will work with the developer and GBA representative to set up a Sustainability Meeting. Project Designers should attend this meeting.

Step 4

SUSTAINABILITY MEETING
Development team, URA contact and GBA representative will meet to discuss project, current sustainability goals expressed by early checklist / questionnaire, and other opportunities.

Step 5

FORMALIZE SUSTAINABILITY PLAN
GBA will formalize recommendations of the Sustainability Meeting into a memorandum. The developer will complete a final Sustainability Plan, which the URA will use as a touchstone throughout project development. Three (3) copies of the Sustainability Plan will be signed by each party, and each party shall keep a copy.

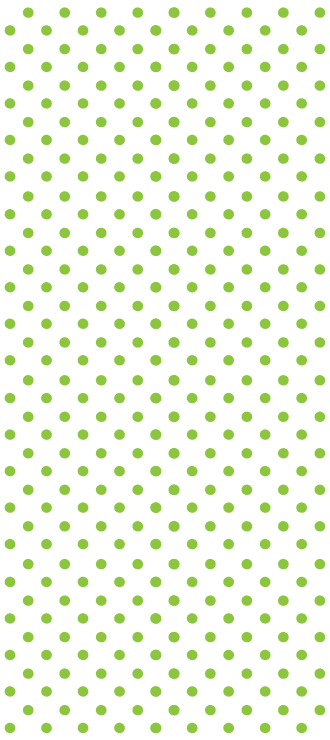
