Compare this to RGP and HAP which use more funds but serve fewer residents/units. Note the different types of impacts these programs create

The survey is officially closed with 662 surveys completed. About 70% of Pittsburgh neighborhoods are represented with 1 or more surveys completed by residents. More details will be presented at the September board meeting as the survey closed on July 31<sup>st</sup>

The Advisory Board will vote on a draft allocation as a part of the October meeting. The URA will then post the draft plan for public comment.

The HOF Advisory Board will utilize public comments and feedback to finalize and vote on the 2025 HOF Allocation Plan at the November meeting. The final plan will then be discussed and voted on at the November URA Board of Director's Meeting and then by City Council by end of the year.

#### G. Grandview South Homes: Affordable Rental Units (RGP Loan

Brooke Gwin, URA Residential Department

Request for authorization to enter a RGP loan agreement, in an amount not to exceed \$625,000 sourced from the HOF, with Grandview South Homes, L.P., or related entity for the construction of 31 scattered site units located in the Allentown neighborhood, Ward 18, City of Pittsburgh. Grandview South Homes is a nonprofit organization who is developing the project. Project also financed by LIHTC equity (RBC), DCRP, PHFA, and a deferred developer fee. TDC = \$17,170,379.Mix of 2 and 3 bedroom homes at 60% AMI or below. 4 at 20% AMI, 7 at 50% AMI, 20 at 60% AMI, and 18 of 33 parcels owned by URA. Construction set to be completed by September 2025.

## H. HAP Updates

Quianna Wassler, Chief Housing Officer at the URA

Choice Neighborhoods

The URA will be committing \$200,000 of HOF (HAP 2024) funds to the above named project in the Bedford Choice geographic area in the Hill District. URA affiliate PHDC will run the program with the URA's support. The program will provide financial assistance to homeowners to make façade and interior repairs, as long as the property is located within the Bedford Choice geographic area. They estimate that about 40 households will benefit from this funding.

HAP Pilot - Action Housing

HAP was created to help improve safety and health of low-income homeowners in need of home repairs and has helped over 300 residents since opening.

2024 HAP allocation amount is \$3.05 million. The URA is proposing a pilot program with Action Housing in the amount of \$1.5 million to administer and oversee the 2024 HAP process from opening to completion. Under this pilot, Action Housing will administer everything from opening the application to overseeing construction. Action Housing anticipates that they can complete 35-40 projects with the \$1.5M in funding in approximately 8 months. HAP will benefit from Action Housing's more streamlined application portal which has been used for non-Action Housing programs before. Action Housing is charging an admin fee of 10% or \$150,000 to administer the contract. This proposal will go before the URA Board of Directors, and will take 4-6 weeks following this to fully open the application.
