E. Housing Stabilization Program

- Guideline Changes
 - Eligible Uses:
 - 1- Move-in assistance which may include: a First month's rent; last month's rent; Security deposit; utility deposits
 - 2- Utility in arrears
 - 3- Rent in arrears
 - 4- Mortgage in arrears
 - Subsidy Amount
 - Maximum Assistance currently \$6,000 per household. Proposed to make the change to be \$3,000 per household.
 - Time Period between Subsidy for applicants.
 - o Currently 3 years; propose to change to 2 years.
 - Maximum Assistance Special Circumstance Exceptions

 Allow the applicant to receive \$4,500 for special circumstances listed below:

A discussion was held regarding the proposed changes:

Alan Sisco noted that he likes flexibility in supporting the special circumstances.

Tanika Harris questioned that although there was data collected in the past. Do the requested changes prepare us for what's to come. She proposed to keep the maximum at \$6,000 for assistance.

Quianna Walser- Reminded the board that there is an appeal process built into the guidelines.

Darius Wallace- Agreed that there should be a decrease in the maximum amount in the someone could borrow but suggested that cut be made to \$4,500 per household.

A motion was made- To keep the eligible uses specific to Rent in arrears and Mortgage in arrears. The motion would also include changing the time between subsidy to 2 years. In addition, the Maximum an applicant could receive with exemptions would be \$4,500.

Elly Fisher- Noted that changing the guidelines to \$3,000 per household helps us help more people. In addition, it would be easier for the administrators to administer the program.

Natalie from action housing talked about how many people we could help considering the changes proposed. Because the dollar amount received was less than half the amount spent on rental assistance last year. Their focus was on being able to serve people with what they need and not more than what they need. This would allow all the funding to go further.

Another motion was made- The eligible uses as set forth should remain the same. The only guideline change recommended is to change the time that an applicant can apply for assistance again from 3 years to 2 years.

F. Legal Assistance Program

- Guideline Changes
- LAP-H RFP
 - Add Estate Planning as an eligible service.
 - Each client will be eligible to receive a maximum of \$5,000 legal assistance.
 - There will be a change to the Ami calculation that are listed in the proposed guidelines.

A motion was made- Move to add estate planning as an eligible service to the Legal Assistance Program for Homeowners.

Quianna Wasler- Clarified that LAP- T is for tenants which assist with mediation, lawyer of the day etc. There is also a Lap- H for homeowners. We have consistently brought both programs jointly for the allocation. As we coordinate with DHS, we have found they do not manage home ownership programs, and they can only support the tenant side. Lap – T will remain the same with potential future talks surrounding AMI. Lap- H we would want to with the changes made, open the program to get a slate of providers that could potentially service this opportunity. The allocation for 2025 was 1 million dollars we are requesting that \$200,000 million of the funding go towards the LAP – H request for proposal. This would leave LAP- T with \$800,000 of HOF funds and LAP – H with \$200,000

A motion was made to authorize the issuing of the RFP with the proposed guidelines in the amount of \$200,000.
